## 15. Apologies

# 16. Declarations of Interests of Members in Contracts and Other Matters and Restriction on Voting by Members

#### 17. Minutes

A Member questioned if the Minutes were entirely accurate as he considered that some details had been omitted. Officers advised that the Minutes were a record of determinations made and not a verbatim record of the meeting.

## 18. The Chairman's Announcements and Correspondence

## (i) Charity Box

The Chairman reported that the charity collection box was circulating for Members to make a donation to support her chosen charities. The Chairman advised that at the Meetings held on 22 May, 2013 a total of £27.10 was collected, and she thanked Members for their donations.

## (ii) Civic Service

The Chairman reminded Members that her Civic Service and Afternoon Tea was to be held on Sunday, 28 July, 2013 at St. Chad's Church, Cannock. Invitations would be sent out later in the week, and she looked forward to seeing them all there.

## (iii) Councillor M.R. Grocott

Councillor Grocott advised the Council that he was no longer a member of the Liberal Democrat Party, but intended to continue to represent his Ward as an independent Member.

## (iv) <u>Datteln Anniversary Celebrations</u>

Councillor Mrs. Stretton advised that the Council's twin town, Datteln in Germany, was due to celebrate its 100<sup>th</sup> anniversary. Members agreed that the Council should write to Datteln offering its congratulations on achieving this significant milestone.

## 19. Question(s) in Accordance with Rule 8

The following question had been submitted under Rule 8 by Councillor M.J. Holder, Deputy Leader of the Council and Crime and Partnerships Portfolio Leader, for the Leader of the Council, which he read out:

"At the Annual Meeting of the Council, Councillor Snape, Leader of the Opposition, during a quite scandalous personal attack on the Leader of the Council, informed the Council as follows:-

'At a recent meeting of the Shadow Cabinet a senior officer of the Council had informed the Shadow Cabinet that no Member of the Labour Group was aware that at least three shops belonging to major national retail brands had closed in Cannock town centre.'

He used this "fact" to attack the abilities of the Administration in general and the Cabinet in particular to manage the affairs of the Council, particularly the regeneration of our town centres.

Would the Leader of the Council share with the Council the results of his investigations into this matter?"

The Leader of the Council provided the following response to the question:

"I thank Councillor Holder for his question which raises serious issues for the Leader of the Opposition.

The claims made by Councillor Snape at the Annual Meeting of the Council were investigated and I am informed by the Chief Executive that at the Shadow Cabinet meeting which took place on 18 March, 2013, there was a discussion on town centre issues, including development of Beecroft Road car park, Portas Fund and Community toilet Scheme. In relation to Portas Funds (Town Centre Business Rates Discount Scheme), the Corporate Director reported that there had been eleven approvals to date of which three were new businesses not previously existing. A Shadow Cabinet Member asked the Corporate Director if he was aware that three national retailers were going to pull out of Cannock Town Centre. The Corporate Director replied that he was not aware.

No part of the question or answer related in any way to Cabinet or Cabinet Members.

I am disappointed that factual information provided by an Officer in good faith has been used by Councillor Snape in this way at a Council meeting.

The whole sorry episode merely goes to show that the Conservative Opposition has now been reduced to trying to mislead the Council and public and putting Council Officers in an embarrassing situation. Councillor Snape should seriously consider his ability to continue as Leader of the Opposition.

The Conservatives have no policies to improve out town centres and this episode shows that they are unfit to be considered as an alternative administration. The electorate clearly agree with this assertion as the Conservative vote in Cannock Chase has fallen year on year since 2011. Long may it continue to do so."

It is vital that this network remains in place and is not weakened by the processes of forced academisation which is not the only solution for school improvement, nor is it proven to be effective.

This Council calls upon Staffordshire Council to fully and unequivocally support community maintained schools against forced academisation. Staffordshire County Council has publicly said that 'the decision is down to individual school governing bodies' and neither Governing Body has expressed an interest to take the academy route. They are being forced. It is time for the Council to put words into action and stop Staffordshire schools being forcibly academised."
