#### 13. Minutes

#### RESOLVED:

## 14. Question in Accordance with the Scheme for Receiving Questions from Members of the Public

In accordance with the Scheme for Receiving Questions from the Public, the Chairman reported that the question submitted by Mr. Brogan would not be dealt with as he was not present at the meeting.

## 15. Chairman's Announcements and Correspondence

### (i) British Armed Forces

It was reported that in the last few months several service men and women had lost their lives whilst on active duty, serving their country. In recognition of this, a two-minute silence was held and the Council offered its condolences to all their families.

## (ii) Councillor Brian Faulkner

The Chairman reported that Councillor Brian Faulkner had recently been ill and was now out of hospital. Members wished him a speedy recovery.

## (iii) Chairman's Charity Box

The Chairman reported that the charity box was circulating for Members to make a small donation to support her charities. A total of £41.00 was donated at the last meeting.

## (iv) Petition

Councillor J.T. Kraujalis presented a petition on behalf of local residents of Girton Road regarding allotment rents.

Having received the petition, the Chairman agreed that it be forwarded to the appropriate Cabinet Portfolio Leader to deal with in the usual way.

#### 16. Question in Accordance with Rule 8

Councillor G. Alcott asked the following question of the Children & Young People Leader in accordance with Rule 8:

"Could the Cabinet Member for Children & Young People tell me:

Following the Labour Government's announcement that over 60's and under 16's are to be allowed to swim free of charge at public swimming baths, can be tell me when this Council propose to introduce that policy?

This would give the senior citizens of the Cannock Chase District Council area an opportunity to lead an active life and also would provide the Council's policy on obesity in young children.

The introduction of this over 60's and under 16's free swim would help the Chase Community Partnerships Sustainable Community Strategy for Cannock Chase District as outlined by the Leader of the Council, Councillor Neil Stanley, relating to health trainers for the District and provide assistance to those most in need".

Councillor N.K. Stanley, Children and Young People Leader, provided the following response:

"An announcement was made on the 6 June 2008 of a new £140m fund to provide free swimming for the over 60's in England only as part of the legacy plans for the 2012 Olympics to get 2 million more adults involved in sport.

£80m is to be used to waive entrance fees for over 60's and promote increased participation in swimming, particularly for under 16's. This revenue funding will be available for the 2009/10 and 2010/11 financial years and will be allocated on a population based formula to unitary and district authorities.

£60m capital fund for pool upkeep (renovation and maintenance) with £10m for 2008/9 financial year with £25m in each of the subsequent two financial years (2009/10 + 2010/11) and local authorities are expected to bid against these sums.

Therefore, Cannock Chase Council will introduce the policy of free swimming for over 60's and promote increased participation in swimming subject to and consistent with the national policy announcement and the fundings made available.

Turning to the position in Cannock Chase and Free swimming for under 16 yr olds:

- This Council has already introduced free swimming for under 5 year olds from 1st January 2007
- This Cabinet, through the Leisure Strategy, has invested £4.2m in establishing a
  new 6 Lane 25m community swimming pool at Rugeley Leisure Centre; this is
  planned to open next month and will significantly expand access to swimming for
  Cannock Chase residents and school children. It is a step change in the quality
  and quantity of swimming facilities in the District.
- There is a commitment within the Council's Leisure strategy to also establish a new swimming pool in Cannock as part of the proposed Chase Leisure Village
- Through the Local Strategic Partnership, South Staffordshire Primary Care Trust has agreed to allocate £12,500 to Cannock Chase Council to provide free swimming sessions for 6 to 16 yr olds over the 2008 summer holidays. The Council is working closely with the PCT to agree the details of this programme and I can confirm that this will be available at both Chase Leisure Centre and Rugeley Leisure Centre from 19 July 2008. The Council will continue to explore and progress free swimming opportunities for 6 to 16 years olds working closely with its partners in the LSP.
- In terms of free access to sporting facilities, Councillor Alcott will also be aware that the Cabinet has included in its Budget for the 2008/09 financial year free use of all tennis facilities and residents are already benefiting from this.

The Council is working very closely with South Staffordshire Primary Care Trust on the introduction of a Health Trainer scheme for Cannock Chase District. This will be a personalised service working with obese individuals, especially from disadvantaged communities, on a one to one basis to improve fitness and assist in weight loss. They will also signpost individuals to other services that may be necessary as part of an overall individualized programme. It is estimated that there are 26,000 people in Cannock Chase District with a Body Mass Index (BMI) of over 30. There is a considerable amount of detailed planning and recruitment that is required to ensure that this is implemented appropriately. 2008/9 will be focused on this preparatory work and starting to establish the scheme and it is intended that the scheme will then be operational for the 2009/10 financial year.

The introduction of free swimming locally for under 16yr olds this summer, the opening of the new swimming pool at Rugeley next month, the proposed new swimming pool for Cannock, free access to tennis facilities and the planned introduction of a Health Trainer scheme for obese individuals is all evidence of the significant improvements and opportunities being provided to residents, children and young people living in Cannock Chase".
